I. CALL TO ORDER

Trustee President Mr. Royall called the meeting to order at 3:05 and thanked the committee members for attending. He introduced the interim CFO, Mark Johnson.

II. MINUTES

Motion:

proposed by Mr. Moore and seconded by Mr. Hager that the minutes of the March 19th, 2014 meeting be approved as distributed. Motion approved.

III. REPORT OF THE PRESIDENT

Mr. Royall suggested that the board should begin discussing a president-elect. With advance planning, this candidate could prepare to serve by attending meetings and learning about the president's responsibilities. The committee agreed.

IV. REPORT OF THE FOUNDATION

Foundation Board President Mr. Rawles reported that the Foundation Investment Committee has successfully refinanced the bonds and the board is extremely pleased with the outcome. The Real

Estate Foundation has been brought under the auspices of the Foundation and is now a committee. This committee has been tasked with examining real estate opportunities that could supplement the existing campus. Additionally, interest in the Oaks has increased and the museum anticipates an offer soon.

V. REPORT OF THE DIRECTOR

Museum director Mr. Nyerges announced that Robin Nicholson, Deputy Director for Art and Education, has accepted the prestigious position of director of the Frick Museum in Pittsburgh. Dr. Sylvia Yount has also been offered a new position of Lawrence A. Fleischman Curator in Charge of The American Wing at the Metropolitan Museum. While the museum is sad to lose two respected colleagues, these opportunities demonstrate the museum's ability to cultivate talent. The director also recognized this as an opportunity to reevaluate the structure of the division's leadership, welcoming any ideas about the two positions' responsibilities.

Mr. Nyerges commended Mr. Johnson for quickly acclimating to the museum in the middle of budget preparation and asked for an update on the museum's finance. Mr. Johnson reported that the department is working toward a full, independent audit, including a sample audit of the collection and an assessment of registrar procedures.

Mr. Johnson summarized the FY15 budget, including the two major exhibitions *Forbidden City* and *Working Among Flowers*. In response to a question about the increase in expenditures over FY14, Mr. Johnson explained that the exhibition expenses have been offset through fundraising, reflected by the Foundation transfer. The museum is working to make such differentiations clearer in budget reports.

VI. OTHER BUSINESS/CLOSED SESSION

At 3:26 pm, the meeting went into closed session with the following motion.
