Mr. Dye reminded the sub-committee that, according to statute, management and control of the Virginia Museum of Fine Arts is vested in the Board of Trustees and its ex-officio members which include the Governor, Speaker of the House of Delegates, and Mayor of the City of Richmond. The board must have at least 25, but not more than 25 nonlegislative citizen members who can serve up to two consecutive five year terms. As of June 30, 2023, one trustee will have completed the maximum number of terms, and six trustees will have reached the end of their first term and will be eligible for reappointment.

**Motion:** Proposed by Mr. Cooper and seconded by Ms. Graham to recommend the following as officers to the full board for a one-year term ending on June 30, 2024:
