I. CALL TO ORDER

III.EXPANSION AND RENOVATION PROJECT UPDATES

Mr. Alex Nyerges, Virginia Museum of Fine Arts (VMFA) Director and Chief Executive Officer, reported that the architects from SmithGroup have completed the schematic design phase of the project. The design has been shared with the Art and Architectural Review Board and is under review by the Division of Engineering and Building within the Commonwealth's Department of Planning and Budget. He noted that the design takes into account several items which could impact the expansion process, including the firewall, underground duct bank, and façade. Mr. Nyerges also noted that renovation of the Leslie Cheek Theater will begin in January 2024 and is scheduled for completion by August 2024.

V. SCHEMATIC DESIGNS FOR THE EXPANSION

Ms. Jame Anderson, SmithGroup Principal-in-Charge, provided a review of the schematic design to-date, visually highlighting the items Mr. Nyerges mentioned in his earlier report and reiterating the importance of complying with legislative intent. Mr. Dayton Schroeter, SmithGroup Lead Designer, presented a revised schematic design for exterior massing. At the presentation's conclusion, Mr. Schroeter and Ms. Anderson responded to questions from the group.
