#### I. CALL TO ORDER

Trustee President Lynette Allston called the meeting to order at 11:18am.

#### II. MINUTES APPROVAL

Proposed by Ms. Allston and seconded by Dr. Betty Neal Crutcher that the minutes of the June 11, 2024 meeting of the Executive and Governance Committee be approved as distributed. Motion carried.

#### III. PRESIDENT'S REPORT

Ms. Allston welcomed the committee and acknowledged new Art and Collection Committee Chair Melinda Hardy and newly elected Foundation Board President Charlotte McGee. She also noted several newly-appointed trustees who will attend these quarterly meetings.

#### IV. DIRECTOR'S REPORT

Alex Nyerges, Virginia Museum of Fine Arts (VMFA) Director and Chief Executive Officer, updated the committee on campaign progress stating that nearly \$25 million has been raised since the group last met. He announced an additional campaign gift from Co-Chairs Elizabeth Locke and John Staelin. Mr. Nyerges also affirmed the schedule for the expansion, noting that the new wing will open in 2028 after approximately 33 months of construction.

### V. CLOSED SESSION

At 11:29am the meeting went into closed session with the following motion:

**Motion**: Proposed by Ms. Allston and seconded by Dr. Crutcher that the Executive and Governance Committee go into closed session to discuss the performance of a specific employee, particularly to discuss the Director's annual goals and performance. The relevant exemption is Section 2.2-3711(A)(1) of the Code of Virginia. Motion carried.

**Motion:** Proposed by Ms. Allston, seconded and carried that the Executive and Governance Committee come out of closed session and to certify the closed session just held was conducted in compliance with Virginia's state law, as set forth in the Certification Resolution distributed.

At 12:25pm, a roll call vote was taken, the results of which are outlined in the Certification Resolution included with these minutes, and the meeting resumed in open session.

Motion: Proposed by Ms. Allston and seconded by Mr. Ken Dye that the Executive and Governance Committee ratify the action discussed in closed session, which was that Mr. Nyerges, VMFA Director and CEO receive the maximum budgeted for his performance bonus and one-time payment for a delay in actions approved in 2023. Motion carried.

**Motion:** Proposed by Ms. Allston, seconded and carried that the Executive and Governance Committee come out of closed session and to certify the closed session just held was conducted in compliance with Virginia's state law, as set forth in the Certification Resolution distributed.

At 12:40pm, a roll call vote was taken, the results of which are outlined in the Certification Resolution included with these minutes, and the meeting resumed in open session.

**Motion:** Proposed by Ms. Allston and seconded that the Executive and Governance Committee ratify the deaccession as discussed. Motion carried.
