I. CALL TO ORDER

At 12:37, Trustee President Bill Royall called the meeting to order and thanked the board members for attending.

MINUTES APPROVAL

III. FORBIDDEN CITY UPDATE

REPORT OF THE PRESIDENT

Li Jian, E. Rhodes and Leona B. Carpenter Curator of East Asian Art, presented highlights from the Forbidden City exhibition. Mr. Nyerges acknowledged that Li Jian exemplifies the importance of curatorial scholarship at VMFA.

IV. MODERN AND CONTEMPORARY ART UPDATE John Ravenal

Mr. Nyerges congratulated John Ravenal, Sydney and Frances Lewis Family Curator of Modern and Contemporary Art, on his recent promotion to become the Executive Director of deCordova Museum and Sculpture Park in Lincoln, MA. He announced that Mr. Ravenal would still curate the upcoming Johns/Munch exhibition. Mr. Ravenal expressed gratitude to Trustees and VMFA colleagues past and present for their support. His presentation highlighted selected projects and acquisitions representative of his time at VMFA. He emphasized the importance of gifts of art and funds to buy art and shared his excitement surrounding Johns/Munch. He reinforced the value of nurturing curators over time to reflect their vision and VMFA's institutional strategy.

Mr. Royall thanked those who attended the recent joint board retreat for strategic planning. He commented that the new strategic plan will be transformational and is on schedule to be submitted for board approval in March.

V. REPORT OF THE DIRECTOR

Mr. Nyerges introduced new Chief Financial Officer Hossein Sadid, former CFO of the University of Richmond. Laura Keller, Assistant to the Secretary of the Foundation, led a demonstration of Huddle, an online tool used by VMFA Trustees, Foundation directors and staff to share documents and meeting dates.

VII. REPORT OF THE FOUNDATION

Foundation Board President Kelly Armstrong thanked those who attended October's successful gala in support of *Forbidden City*. She informed Trustees that the sale of The Oaks closed last month, and the proceeds will be invested in the Foundation endowment. She added that, at \$252 million, the Foundation endowment is 2.1 percent above its benchmark, up 3.8 percent this year. Ms. Armstrong stated that the focus has been to develop good cash flows and accurately manage liquidity to keep the maximum amount of funds invested.

VIII. GOVERNMENT RELATIONS REPORT

Government Relations Manager David Bradley updated Trustees regarding state budget cuts, stating that the Commonwealth is still looking for \$100 million to balance the budget and both higher education and local government industries in particular received significant cuts.

Mr. Bradley attended an economic briefing through the Chamber of Commerce where VMFA was recognized for promoting cultural diversity through *Forbidden City*. He reviewed a recent trip to China where The Honorable and Mrs. McAuliffe joined VMFA leadership to meet with Chinese officials and Palace Museum staff. He noted that the Chinese embassy has offered VMFA positive feedback surrounding *Forbidden City*. Mr. Royall commended Mr. Bradley for his expertise in the government relations field.

IX. REPORTS

• <u>Operations Committee</u> – John H. Hager, Co-Chair and Stephen Bonadies, Deputy Director for Collections & Facilities Management

Mr. Hager reported that the committee discussed information technology and infrastructure, noting that technology becomes increasingly important year after year. The committee also reviewed the progress of the Robinson House visitor center, which aims to be open in time for the 2015 World Road Cycling Championships taking place in Richmond.

• <u>Resources & Visitor Experience Committee</u> – Meg Clement, Chair and Claudia Keenan, Deputy Director for Resources and Visitor Experience

Ms. Clement informed Trustees that the committee discussed how to better define membership categories and improve the general visitor experience at VMFA.

Ms. Keenan presented the fundraising report as of November 30, 2014. Against a goal of \$6.2 million, fundraising progress totaled \$2.9 million. She shared news that the Foundation received a \$600k grant from the Mary Morton Parsons Foundation, which must be matched within a year. She noted that VMFA is close to its fundraising goal for *Forbidden City* despite poor sales over the Thanksgiving holiday due to inclement weather.

• <u>Art and Education Committee</u> – Susan S. Goode, Chair and Dr. Lee Anne Chesterfield, Interim Deputy Director for Art & Education

Ms. Goode summarized the morning's meeting, in which Trustees were updated on upcoming exhibitions, including a presentation from Mr. Ravenal about *Johns/Munch*. The meeting concluded with a tour of the library led by Head Librarian Lee Viverette, and Ms. Goode encouraged all Trustees to contact Ms. Viverette for a library tour.

• <u>Fiscal Oversight Committee</u> – John A. Luke, Co-Chair and Hossein Sadid, Chief Financial Officer

Mr. Luke commented that the committee meeting provided Trustees with a valuable opportunity to learn more about Mr. Sadid's leadership priorities. Mr. Sadid thanked Trustees for the opportunity to work with them. He advised that he has already developed a Q1 financial forecast, currently available for review on Huddle, noting that the Foundation is already ahead year-to-date from FY14.

Mr. Sadid informed Trustees that the independent audit is progressing well, though behind schedule, and that a new position for an internal auditor has been approved.
