I. CALL TO ORDER

Chair Jil Harris called the meeting to order at 2:05pm.

III. EDUCATION UPDATES

Director of Education Celeste Fetta Neff presented an overview of the museum's Teen Stylin' program, in which students in grades six through twelve design a garment inspired by a work in VMFA's permanent collection. She shared photos of the winning designs in various categories, one of which was on display at the meeting. Ms. Neff then discussed *The Dirty South* Virtual Speaker Series and Summer Film series, noting that these programs, in conjunction with the special exhibition, will utilize film and bi-weekly virtual conversations between scholars, curators, and visual and musical artists to explore poetry, visual and sonic culture, contemporary southern hip-hop, and legacies of traditional southern aesthetics.

IV. VMFA ON THE ROAD/STATEWIDE UPDATES

Mr. Jeffrey Allison, Manager of Statewide Programs and Exhibitions and the Paul Mellon Collection Educator, noted recent VMFA on the Road residencies in Church Hill, Fairfax, and Onancock on the Eastern Shore. He reported that the Artmobile will hold a residency at Natural Bridge and work with the museum's Distance Learning Program, noting the opportunity to connect the Virginia Arcadia: The Natural Bridge in American Art exhibition with the current VMFA on the Road exhibition, A View from Home: Landscapes of Virginia. Mr. Allison then announced new statewide partners: IX Art Park, the Historical Society Eastern Shore Virginia, and the Tephra Institute of Contemporary Art. He also discussed current statewide museum level and educational exhibitions which include Carl Chiarenza at Piedmont Arts, Ansel Adams: Composition in Nature at the Taubman Museum of Art, A New Mosaic: African American Art from the Virginia Museum of Fine Arts at the Science Museum of Virginia, and What's So Radical About Impressionism at the Historical Society Eastern Shore Virginia.
