I. CALL TO ORDER

Trustee President Dr. Monroe Harris, Jr. called the meeting to order at 4:02pm.

II. APPROVAL OF MINUTES

**Motion:** Proposed by Mr. David Goode and seconded by Ms. Meg Gottwald that the minutes of the March 16, 2021; June 8, 2021; and September 15, 2021 meetings of the Executive and Governance Committee be approved as distributed. Motion carried.

III. PRESIDENT'S REPORT

Dr. Harris thanked the gathered committee members and provided an overview of the agenda.

IV. DIRECTOR'S REPORT

a. Closed Sessions

At 4:04pm the meeting went into closed session with the following motion.

**Motion:** Proposed by Dr. Harris and seconded by Ms. Gottwald that the Executive Committee meeting go into closed session to consult with legal counsel employed or retained by a public body regarding specific legal matters requiring the provision of legal advice by such counsel. The relevant exemptions are Section 2.2-3711(A), subsections (8) and (29) of the Code of Virginia. Motion carried.

At 4:23pm, by motion proposed, seconded, and carried, the meeting resumed in open session. A roll call vote was taken, the results of which are outlined in the Certification Resolution of these minutes.

b. Open Session

Director and Chief Executive Officer Alex Nyerges reported that attendance has continued to increase to pre-pandemic rates. Recent exhibitions, including *Virginia Arcadia: The Natural Bridge in American Art* and *The Dirty South: Contemporary Art, Material Culture, and the Sonic Impulse*, surpassed attendance goals with 62,127 and 54,122 visitors, respectively. Mr. Nyerges noted that *The Dirty South* received positive reviews from *The New York Times* and *The Los Angeles Times*. He encouraged board members to attend the *Ansel Adams: Compositions in Nature* exhibition which opened September 25, 2021 with 7,847 visitors having attended thus far. Mr. Nyerges added that more exhibitions will open in October, including *Fine Arts & Flowers* and *Man Ray: The Paris Years*.

Mr. Nyerges outlined the museum's updated safety protocols in relation to COVID-19, noting the requirement for all museum and foundation employees, volunteers, and contractors to be fully vaccinated by November 1, 2021.

Chief Development Officer and Deputy Director of Advancement Tom Gutenberger reported that the Campaign, at \$193 million, is at 53% of its goal. Of these funds, \$68 million is from private support. Mr. Gutenberger recognized the hard work of the Campaign Committee's regional teams in identifying local potential donors for the leadership phase of the campaign. He shared that a staff Campaign Launch Committee has been formed to plan the campaign's public launch in the fall of 2022.

Chief Strategy Officer and Deputy Director for Strategic Planning, Government, and Board Relations Caprice Bragg reviewed a draft of the operating agreement between the museum and the VMFA Foundation which reflected many of the same provisions as the previous agreement. The updated document includes an automatic five-year extension and reinforces the separation of the legal entities. There was a consensus among the Executive Committee that the Operating Agreement should be approved.

Mr. Nyerges shared preliminary plans for a ceremony unveiling a plaque featuring the museum's land acknowledgement. Ms. Bragg then spoke about the budget requests that VMFA has submitted to the Governor's Office. Mr. Nyerges noted that staff is waiting for further instructions from government officials on the Transforming Monument Avenue Project.

c. FY21 Director's Report and FY22 Director's Goals

Mr. Nyerges reviewed FY21 highlights and accomplished goals, which included reopening safely to the public after a 3-month pandemic closure; offering international and "homegrown" exhibitions; transitioning programs online; advancing the leadership phase of the 365 Campaign; securing a world-class architecture and design firm for the building expansion; and approving the 2025 Strategic Plan.

At 5:02pm the meeting went into closed session with the following motion.
