## I. CALL TO ORDER

Trustee President Dr. Monroe Harris, Jr. called the meeting to order at 3:03pm.

#### II. APPROVAL OF MINUTES

# **Motion:** Proposed by Dr. Harris and seconded by Ms. Meg Gottwald that the minutes of the October 14, 2021 meeting of the Executive and Governance Committee be approved as distributed. Motion carried.

#### III. PRESIDENT'S REPORT

Dr. Harris reported that a dedication for the museum's Land Acknowledgement took place on November 9, 2021. He recognized Trustee Vice President Lynette Allston for her assistance in reviewing the language and her remarks during the dedication. Dr.

Harris also congratulated VMFA Director and Chief Executive Officer Alex Nyerges for receiving the American Institute for Architects Architecture Medal for Virginia Service.

#### IV. FOUNDATION PRESIDENT'S REPORT

VMFA Foundation Board President Jay Olander reported that the Foundation Directors met on November 9, 2021, and among other things, unanimously approved the Operating Agreement between the museum and the Foundation. He also reported that as of October 31, 2021 Foundation assets were at an all-time high of \$327,575,428.

## V. DIRECTOR'S REPORT

Mr. Nyerges opened with an update on masking and vaccination initiatives, and noted that the VMFA met a vaccination requirement by November 1, 2021. He reported that attendance continues to increase to pre-pandemic rates. Mr. Nyerges encouraged board members to attend the *Ansel Adams: Compositions in Nature* and *Man Ray: The Paris Years* exhibitions, which as of November 7, have an attendance of 17,763 and 3,851 respectively.

Chief Curator and Deputy Director for Art and Education Michael Taylor provided an update on the building expansion, explaining that the architecture firm, SmithGroup, has completed the program validation phase of planning and is now in the midst of rightsizing.

Chief Development Officer and Deputy Director of Advancement Tom Gutenberger reported that the Campaign, at \$194 million, is at 53% of its goal. Of these funds, \$69 million is from private support. Mr. Gutenberger recognized members of the Campaign Committee who have recently hosted cultivation events in Richmond and Virginia Beach. Mr. Gutenberger completed his report by announcing that membership has increased to 31,000 member households.

Director of Government Relations Katie Payne noted that Governor-Elect Youngkin's administration will take office in January 2022. She noted that the upcoming legislative session will include a biennium budget, and highlighted the consideration process. Mr. Nyerges noted that VMFA is awaiting further direction from the Governor's Office relative to the Monument Avenue Project.

Mr. Nyerges concluded his report by asking Senior Assistant Attorney General Cynthia Norwood to update the Committee on proposed amendments to the Bylaws. Ms. Norwood explained that the proposed amendments which relate to virtual and telephonic participation based on family, medical, and personal reasons.

#### VI. CLOSED SESSION

At 3:32pm the meeting went into closed session with the following motion.
