## I. CALL TO ORDER

President Monroe Harris called the meeting to order at 12:07pm.

## II. APPROVAL OF MINUTES

**Motion:** Proposed by Dr. Harris and seconded by Ms. Cindy Conner to approve the minutes of the June 16, 2021 Full Board meeting as distributed. Motion carried.

## III. REPORT OF THE PRESIDENT

After welcoming everyone, Dr. Harris provided an overview of the day's agenda, noting that representatives from SmithGroup were present to give an update on the expansion process.

## IV. REPORT OF THE FOUNDATION PRESIDENT

Foundation Board President Jay Olander reported that the Foundation Board of Directors met in late August and learned that the Foundation ended FY21 with a balanced budget and that the endowment is at \$328,757,623.

# V. BEST PRACTICES FOR AGENCY TRUSTEES

Senior Assistant Attorney General Cynthia Norwood presented an overview of best practices for agency trustees in the Commonwealth of Virginia. She highlighted statutory duties and requirements for the Freedom of Information Act.

## VI. REPORT OF THE DIRECTOR AND CHIEF EXECUTIVE OFFICER

Mr. Alex Nyerges, Director and Chief Executive Officer, reported that attendance has continued to increase to pre-pandemic rates, with current visitation standing at 104,149. Recent exhibitions, including *Virginia Arcadia: The Natural Bridge in American Art* and *The Dirty South: Contemporary Art, Material Culture, and the Sonic Impulse* surpassed attendance goals with 62,127 visitors and 54,122 visitors, respectively. Mr. Nyerges noted that *The Dirty South* had received positive reviews from *The New York Times* and *The Los Angeles Times*. He encouraged board members to attend the upcoming exhibitions, *Ansel Adams: Compositions in Nature* and *Man Ray: The Paris Years.* Mr. Nyerges provided a brief update on the Monument Avenue Project, stating that staff is assembling a memorandum of understanding with the City of Richmond and working to complete searches for two positions.

Mr. Nyerges invited Mr. Tom Gutenberger, Deputy Director for Advancement, to provide an update on the Capital Campaign. Mr. Gutenberger reported that total gifts and commitments to the \$365 Million Campaign stand at \$191 million or 52% of its goal. Of these funds, \$66 million is from private support. Support from the Commonwealth of Virginia is \$125 million in a 2:1 match. Mr. Gutenberger added that overall cash and pledges for the year is at \$14.5 million.

## VII. COMMITTEE REPORTS

## a. Art and Collections Committee

Art and Collections Committee Chair Meg Gottwald reported Paul Mellon Curator and Head of the Department of European Art Sylvain Cordier presented plans for displaying the art collection of Jordan and Thomas A. Saunders III. Additionally, Assistant Chief Conservator Debbie Linn discussed the process for repairing and preserving the coating of Jaume Plensa's *Chloe*, which is now underway.

# b. Education Committee

Education Committee Vice Chair Betty Crutcher reported that Director of Education Celeste Fetta and Director of Statewide Programs and the Paul Mellon Educator Jeffrey Allison shared updates about *The Dirty South* exhibition programming, augmented reality tours and experiences, and *VMFA* on the Road residencies across the Commonwealth.

# c. Art Acquisitions Sub-Committee

At 12:45pm the meeting went into closed session with the following motion:

Fiscal Oversight Committee Chair David Goode reported that Chief Financial Officer and Deputy Director for Finance and Administration Hossein Sadid presented information. For the 85<sup>th</sup> consecutive year, the museum's budget was balanced for FY21. Additionally, revenues and expenses are on track for FY22 at this stage. Mr. Goode concluded that remaining reserves are also being monitored should they be needed in FY23.

#### e. Building Committee

Building Committee Chair Charlie Whitaker reported that representatives from SmithGroup shared key themes and priorities that have emerged from Program Validation discussions with 70 internal stakeholders, project activities to-date, and next steps in the process. SmithGroup representatives, led by Principal-in-Charge Jamé Anderson, provided an overview of that presentation to the Board.
