III. PHOTOGRAPHY COLLECTION PLAN

Sarah Kennel, Aaron Siskind Curator of Photography and Director of the Raysor Center for Works on Paper, provided an overview of the history and strengths of VMFA's photography collection. Dr. Kennel described a collecting strategy that will expand the collection to continue acquiring works of the highest quality and historical importance, acquire works that provide "connective tissue" between focus areas, seek work to make the collection unique, and explore synergies with other areas of the museum's permanent collection.

IV. WHITFIELD LOVELL EXHIBITION

Alexis Assam, Dr. Regenia A. Perry Assistant Curator of Global Contemporary Art, discussed an upcoming Whitfield Lovell exhibition. *Whitfield Lovell: Passages* was organized by Dr. Michelé Wige, Curator of Exhibitions at the American Federation of Arts, and will be curated for VMFA by Ms. Assam in June 2023. The exhibition highlights the artist's masterful conté crayon drawings, assemblages, and multi-sensory installations that focus on aspects of African American history while raising universal questions about identity, memory, and America's collective heritage.
